
Concerns: **export to EGYPT**

Please be informed that the Egyptian Ministry of Trade and Industry recently issued decrees that will affect the import procedures for the goods listed in annex.

- Decree 991/2015 states that these goods are from now on added to the list of Regulated Products for which a Certificate of Inspection (COI) must be issued for customs clearance in Egypt.
- Decree 43/2016 states that the producers or brand owners of these goods should register with Egypt's General Organization of Export and Import Control (GOEIC). This registration can be done online on GOEIC website:

These Decrees will take effect as from **15st of March 2016.**
SGS is authorized to issue Certificates of Inspection (COI) for Egypt.
